How to fill out a traffic accident report?

To make filling out the form easier for you, we are providing a detailed overview of all the information that a traffic accident report should contain:

- 1. Date of the accident fill in the date and time as accurately as possible.
- **2. Location** state the place where the accident occurred, again as accurately as possible. Street name and house number, or the kilometer marker of the road, in which direction, near which municipality, parking lot at a shopping center, etc. (e.g., D11, 152 km, direction Hradec Králové or parking lot Albert, Červené vršky, Benešov).
- 3. Injuries, including minor ones check the box if this occurred.
- **4. Property damage to other vehicles or objects** check the box if other vehicles or objects were damaged in the accident (*traffic sign*, *lamp*, *guardrail*, *fence*, *etc.*).
 - Keep in mind that if you check "yes" in points 3 or 4, it is necessary to call the Police of the Czech Republic at 158 for such an accident.
- **5. Witnesses** as much information as possible, names, addresses, phone numbers, etc. They are useful for clarifying any different views of the accident from both involved drivers.
- **6. Policyholder/Insured** for both vehicle A and B. Use the proof of insurance i.e., the "Green Card" (stated on the card in the upper right in point 9). Always state the full name, permanent address, and contact phone number, or the full company name and address if it is a company vehicle.

7. Vehicle - applies to both vehicle A and B. State the makes, models, registration numbers, and country of registration, which you can get from the small technical certificate or the "Green Card" (points 5+7).





8. Insurer- you will find this information on the "Green Card" as well. It is necessary to fill in the names of the insurance companies with which the vehicles are insured (point 10), the insurance policy number, the number and validity of the "Green Card" (points 3+4).

You can also add the address of the insurance company's branch, but it is not necessary. Check whether the vehicle has comprehensive insurance.





Note: The Green Card number is the entire number including the Country Code/Insurer's Code/Number. The policy number is only the number after the last slash, in this case 4413614252.




- **9. Driver** you fill this in for both vehicle A and B; this is the data of the drivers i.e., the participants in the accident. The car could have been driven by someone other than its owner. The required information is first name, last name, date of birth, permanent address, and contact details. Also, fill in the driver's license numbers of both drivers, including their validity and the category of driving license.
- **10. Points of initial impact** in this case, it is necessary to mark with an arrow on the displayed diagrams of vehicles A and B the places where the vehicles collided, including the direction of impact.
- **11. Visible damage** in this section, briefly state which parts of your vehicle were damaged after the accident.
- **12. Circumstances of the accident** mark with a cross the points that correspond to the situation of both vehicles during the accident. Then, write the number of marked boxes in the square below. You can mark more than one situation.
- **13. Sketch of the accident at the moment of impact** in the designated space, try to draw the course of the accident as accurately as possible. Sketch the road, use arrows to indicate the direction of travel of the vehicles, write down the names of the streets or roads, draw traffic signs, traffic lights including the lit colors (red, orange, green), or it is sufficient to write "green light at the traffic light," etc. It is important to label vehicles A and B in the sketch; draw the situation from a bird's-eye view and simply represent the vehicle as a rectangle with the label A or B.
- **14. Remarks** space for both drivers' perspectives on the accident. We recommend that it is stated here who is the at-fault party and who is the injured party. For example, write: INJURED PARTY, AT-FAULT PARTY, I AGREE WITH MY FAULT, I AM THE AT-FAULT PARTY OF THE ACCIDENT, etc.
- **15. Signatures of the drivers** the form must be signed by both drivers, but unless it is specifically stated in the form (e.g., in the remarks section) that one of the drivers admits fault, the signature only confirms the authenticity of the filled-in data.

Tips

- If you have any doubts, call our client helpline for drivers at 296 333 666, option 1.
- We recommend taking photos as soon as possible after the accident (ideally before the vehicles are removed from the road); it may be useful when resolving the insurance claim.
- The original of the record stays with the injured party; the at-fault party takes a photo of the original on their mobile phone and keeps the remaining copies.
- If the at-fault party refuses to fill out the record, it is necessary to call the police to the scene of the accident.
- In the case of a multiple-vehicle accident, the at-fault party fills out as many accident records as there were vehicles hit. The at-fault party is listed as vehicle A on each record. The first record includes vehicles A-B, the second record A-C (vehicle B is crossed out and replaced by C), and so on. These vehicles will also be shown in the accident sketch of each record.
- Each participant should fill out their part of the record in their own hand and should not fill in information about the other participant for them.
